## POLICY ON WORLD CONGRESS ANCILLARY FUNCTIONS - PLEASE READ CAREFULLY:

The NAHRS approval, which may be granted or denied by the NAHRS at its sole discretion, is required for all exhibitor-sponsored ancillary functions. Requests for such activities must be submitted in writing via the Ancillary Function Request Form to the NAHRS Meetings & Exhibits Manager by August 14, 2015. The request must specify date, time, location, type of function and anticipated attendance. Ancillary functions will only be approved for times that are not in competition with the World Congress program, in the sole opinion of the NAHRS. The NAHRS is not holding meeting rooms at the InterContinental Hotel Miami for exhibitor use. The exhibiting company must secure their own meeting/function space, whether it be at the InterContinental Hotel Miami or elsewhere, and pay any and all required fees and costs directly. If it is determined that an unapproved ancillary function of any sort has taken place or is scheduled to take place, the NAHRS may deny the exhibitor space installation or access to the exhibit area, close or remove the exhibitor's exhibit space, prohibit the exhibitor's participation in future World Congresses, or take such actions as the NAHRS, in its sole discretion, deems appropriate.

The allowed ancillary timeslots below are not exclusive. There may be more than one exhibiting company hosting ancillary functions during any given time period.

The NAHRS will communicate approval or denial of all ancillary function requests by September 1, 2015.
