Stress First Aid (SFA) is an evidence-informed self- care, peer support and leadership framework that uses a set of supportive actions designed to help emergency responders assist themselves and each other in reducing the negative impacts of stress. The SFA framework recognizes that stress can be multi-faceted, cumulative and resulting from multiple sources (e.g. family stressors, 'wear and tear' etc.), not just disasters or "critical incidents". Day one is intensive training in Stress First Aid; Day two, participants will present the material and discuss their roles as trainers. Both days of the training are required for certification as a trainer by the First Responder Center of Excellence.

Crews will practice hose and nozzle management techniques that setup a stretch for success. Crews will be given tactical considerations for finding victims while stretching the attack line. On the second day of training, crews will integrate with the Truck and Command programs.

These companies can be split into two teams, "The Two Team Concept", The Outside Team and The Inside Team. Each team has priorities to accomplish and can include Inside team-locate, confine, and transmit fire location, primary search, checking for extension and overhaul. The Outside team options are vent-enter-search (VES), outside vent, gaining access, vertical ventilation, and aerial operations (if arriving on an aerial apparatus). In this 2-day class, participants will be given the opportunity to practice some of the skills needed to be successful in conducting these functions. In the afternoon of the 2nd day attendees will join the Engine Track and Command Track and operate in a complex scenario with live fire.

A lecture on fire ground rehabilitation that focuses on effective techniques for different weather scenarios and involves tabletop drills and hands-on practice. The "Firefighter Down MAYDAY" presentation emphasizes treating injured firefighters, removing contaminated gear, assessing non-fire-related injuries, and safe transport, while practical exercises involve trauma assessment, gear removal, transport goals, and ER turnover. This track will join the others on day two with live fire scenarios for hands-on patient transfers from the fire ground to the ambulance and hospital.

It wasn't until I received a rude awaking and nearly died on the job that I took stock of my personal life and career where I was faced with the hard truth that I was failing miserably. I took the lessons learned over half my life from some of the best mentors both on and off the job to turn everything around. Simple actions led to personal goals and aspirations coming to fruition but also the goals and aspirations of many of my teammates. Together we all started to thrive on and off the job. My goal is to share these simple steps so that the next generation of leaders doesn't have to play catch up as they progress in their career. I wish I had listened earlier and not wasted years of not only my career but the careers of the firefighters I was given the opportunity to serve.

2/21/2024	8:00 AM	9:45 AM	Hospital Area Command	Virginia Office of EMS - Continuing Education Credit Category 1 BLS - 15 ALS - 20 On the evening of Sunday, October 1 st , 2017, more than 22,000 concert goers were enjoying the last night of a three-night country music event, known as the Route 91 Harvest Festival. The venue for this event was a 17.5-acre, outdoor festival lot on the south end of the "Las Vegas Strip". This venue lies within jurisdictional boundaries of the Clark County Fire Department (CCFD). What began as a wonderful October evening in the cool desert air suddenly became a terrorizing struggle of life and death. At approximately 10:06 P.M., a lone gumman opened fire on the concert grounds from a hotel suite on the 32 nd floor of a resort across the street from the venue. Within a 10-minute time frame, the killer fired more than more than 1,000 rounds at the concert venue resulting in more than 800 people being injured, over 420 of them suffering at least one gunshot wound. The 22,000 concert attendees fled in every direction, and the majority of those injured were transported to area hospitals by means other than EMS units. This included personal vehicles, cabs, public transportation, rideshares and other means of transportation to get the care they needed. In totality, 60 people died as a result of their injuries. One of the most notable lessons learned from this incident was the direct result of the extraordinary efforts of an engine company and rescue ambulance from the Henderson Fire Department (HFD). HFD is a neighboring jurisdiction to the CCFD. During the time of the shooting, these two units from the HFD were delivering a patient from a motor vehicle accident to the level II trauma center. The HFD crews were wrapping up and about to head back to their station, when they were suddenly caught in the surge of a several dozen critically wounded patients arriving to the hospital via both EMS transport agencies and private vehicles. Recognizing what was taking place, they immediately began helping the emergency department (ED) staff with p

Using Easy Company commander Major Richard Winters' 10 Principles of leadership, the class discusses a multi-faceted approach to leadership, based on character and leading by example. History shows that leadership is not determined by rank, but by attitude and action. Following the success of the Stephen Ambrose book, Band of Brothers, and the HBO mini-series of the same name, Easy Company's former commanding officer, Major Richard Winters, co-authored a follow-up book entitled, Beyond Band of Brothers: The War Memoirs of Major Dick Winters. In this book, Winters expanded on his wartime experiences and detailed his philosophy of small- and large-unit leadership. Winters summarized his leadership lessons into 10 Principles of Leadership, which are used as a framework for this class. LEARNING OBJECTIVES: 1. Identify the values that are associated with strong leadership. 2. Describe techniques for building credibility as a leader. 3. Discuss the ways that leadership priorities change at different levels of an organization. 4. Explain how a leader's actions and attitude can affect morale. 5. Understand the importance of developing, empowering, and supporting personnel. The class begins with an overview of the D-Day invasion and the role of the 101st Airborne Division in the European Campaign. This orientation and the narrative of the class are enhanced by the instructor's first-hand experiences in Normandy and Belgium as part of a fire service pipes & drums band that participated in the ceremonies surrounding the 75th Anniversary of the D-Day invasion in 2019. Throughout the presentation, video clips and historical photos are used to illustrate situations where Major Winters and the men of Easy Company were faced with leadership dilemmas, and to examine how they succeeded or

After identifying challenges that may be weighing the responder down, we look at some realistic coping strategies, what self-care really looks like and everyday ways to improve quality of life. Leadership will find this useful for personal purposes as well as to support individuals they supervise.

The venue for this event was a 17.5-acre, outdoor festival lot on the south end of the "Las Vegas Strip". This venue lies within jurisdictional boundaries of the Clark County Fire Department (CCFD). What began as a wonderful October evening in the cool desert air suddenly became a terrorizing struggle of life and death. At approximately 10:06 P.M., a lone gumman opened fire on the concert grounds from a hotel suite on the 32 nd floor of a resort across the street from the venue. Within a 10-minute time frame, the killer fired more than more than 1,000 rounds at the concert venue resulting in more than 800 people being injured, over 420 of them suffering at least one gunshot wound. The 22,000 concert attendees fled in every direction, and the majority of those injured were transportation, rideshares and other means of transportation to get the care they needed. In totality, 60 people died as a result of their injuries. One of the most notable lessons learned from this incident was the direct result of the extraordinary efforts of an engine company and rescue ambulance from the Henderson Fire Department (HFD). HFD is a neighboring jurisdiction to the CCFD. During the time of the shooting, these two units from the HFD were delivering a patient from a motor vehicle accident to the level II trauma center. The HFD crews were wrapping up and about to head back to their station, when they were suddenly caught in the surge of a several dozen critically wounde patients arriving to the hospital via both EMS transport agencies and private vehicles. Recognizing what was taking place, they immediately began helping the emergency department (ED) staff with patient treatment, triage, and other tasks needed to handle the more than 200 victims that arrived in an hour

In this book, Winters expanded on his wartime experiences and detailed his philosophy of small- and large-unit leadership. Winters summarized his leadership lessons into 10 Principles of Leadership, which are used as a framework for this class. LEARNING OBJECTIVES: 1. Identify the values that are associated with strong leadership. 2. Describe techniques for building credibility as a leader. 3. Discuss the ways that leadership priorities change at different levels of an organization. 4. Explain how a leader's actions and attitude can affect morale. 5. 

TECC focuses on the medicine during these phases of care and provides guidelines for managing trauma in the civilian tactical or hazardous environment. 
